APPLICATION TERMS AND CONDITIONS

By commencing the application form for the Program ("**Application Form**"), you agree to the following terms and conditions ("**Terms**"):

1. GENERAL

1.1. These Terms relate to your participation in the Program and in the casting process (and diligence process, if applicable) for the Program (together the "**Casting Process**"). These Terms together with the Application Form, form the "application". For the purposes of your application, "**we**", "**us**" and/or "**our**" shall mean Studio Lambert Productions Ltd, and "**Commissioner**" shall refer to the commissioning broadcaster/network, financier and/or distributor of the Program.

1.2. The Program name/title is a working title and is subject to change in our sole discretion. Our decision in this matter shall be final.

1.3 Applications and/or any documents you submit may not be considered if they are incomplete, incomprehensible and/or incorrectly submitted. We do not accept any responsibility whatsoever for any technical failure, malfunction, delays or any other problem which may result in any application and/or documents not being properly received by us by the specified closing date or with the specified timeline (where applicable).

1.4. Closing Date: The closing date for applications is set out in the Application Form. We reserve the right to extend or close the application process at any time in our sole discretion for any reason and without notice.

1.5. Due to the number of enquiries and/or applications we expect to receive, we cannot guarantee that we will read, review or process every application or enquiry, and we will not be able to acknowledge or respond to each and every one. Please note, we will only be contacting those applicants who we wish to put forward to the next stage of the Casting Process. You accept and agree that the Casting Process, including but not limited to the applicants and/or participants selected to participate in the Program, is at our sole discretion. Applications are not guaranteed to be successful. Our decisions in these matters shall be final and there will be no right of appeal against any actions or decisions taken by us on these matters.

1.6. You accept that submitting an Application Form and/or any other documents; receiving any document, phone call and/or correspondence from us; participating in an audition/interview; being shortlisted; participating in any recording day and/or any part of the Casting Process DOES NOT automatically mean that you will be participating in and/or appearing in the Program, and we reserve the right, in our sole discretion, to discontinue your participation in the Casting Process at any time, even if you have been given a date to participate in an audition, interview and/or recording.

1.7. We and the Commissioner shall have no obligation to continue the Casting Process, to include (without limitation) any applicant's participation in the Program, to develop, produce, broadcast, exhibit, exploit or publicise the Program, and/or to make use of any of the Contribution and/or the Personal Media (as defined below) or any part(s) of them.

1.8. By applying to take part in the Program and taking part in the Casting Process, you have fully considered the potential impact (including, without limitation, future considerations) that participating in the Program, if selected, may have on you, your family and/or friends (including without limitation in respect of work/job, reputation, benefits (if applicable) and/or your mental and/or physical health, safety, and wellbeing).

1.9. Filming will take place in the UK, and if you are selected to participate in the Program we will arrange and pay for all necessary travel to attend filming. If you are not resident in the UK, you will need to hold a valid passport and/or visa to participate in the Program if selected, and you confirm that:

1.9.1. you are not aware of anything that may restrict you from entering the UK;

1.9.2. you have not had any previous issues with immigration.

2. YOUR OBLIGATIONS

2.1. If you are invited and/or selected to participate in the Casting Process for the Program, you agree to:

2.1.1. provide us with: (i) valid and original proof of your age and identity (such as a passport or photo driving licence); (ii) valid and original proof of your right to legally live and work in the US (or other country of residence), as requested. **Please note** if you do not provide us with the same as requested and in such form as notified to you, we may discontinue your participation in the Casting Process and/or terminate your participation in the Program (if selected);

2.1.2. participate in any part of the Casting Process relating to the Program at such location(s) and/or using such technology (such as by way of example Skype or Facetime or Zoom) as requested by us and on any dates as mutually agreed;

2.1.3. undertake a medical and/or psychological assessment, conducted by a qualified practitioner, if required by us. You further acknowledge and agree that such practitioner shall share their review, report, information, results and/or findings in respect of such assessment with us and we may share the same with the Commissioner and other authorised third parties as set out in our privacy policy

2.1.4. complete a self-disclosure form; a health questionnaire; a criminal records check and/or such other forms and/or documents, and request a letter and/or medical records from your doctor, as we may require, and you agree to us conducting background and/or other checks on your behalf (including but not limited to criminal records check, DBS checks, Factiva check, Google search, social media search and/or similar);

2.1.5. share such information and/or documents about you, your identity and/or background as requested by us (including but not limited to information relating to: any unspent criminal convictions; criminal and/or civil allegations, investigations or proceedings you have been and/or are involved in; and/or any conduct or anything in your past that may attract negative press or publicity). Please note that disclosing something of this nature to us will not automatically disqualify you from participating in the Program but it is important we know of any relevant issues.

2.2. You confirm that you shall comply with each of the Eligibility Requirements as set out in the Application Form).

2.3 You shall provide us with documentary evidence and assistance necessary to carry out any background searches if so required by us to investigate, review and validate the authenticity of any information provided by you at any time, and in the event such investigation and/or review reveals any information that we feel may adversely affect your suitability to continue to participate in the Casting Process, we may, at our absolute discretion, discontinue your participation in the Casting Process and/or terminate your participation in the Program (if selected) at any time.

2.4 You agree to promptly sign and return a contributor agreement and perform such acts and/or complete such documentation as reasonably requested by us for the Casting Process.

2.5 You agree to follow our directions and instructions during the Casting Process and, if selected to take part in the Program, you agree to abide by any further directions, instructions and/or the rules of the Program as we may notify to you (whether in writing or verbally). You accept that we may alter, change, or add to such directions, instructions and/or rules from time to time in our sole discretion and our decisions in these matters are final.

2.6 You agree to comply with all applicable laws and regulations in connection with the Casting Process, and (if selected) in connection with your participation in the Program, and shall comply with our guidelines and protocols (including without limitation those relating to health and safety) as notified to you.

2.7 You confirm that:

2.7.1 the information supplied on the Application Form and any other documents, as well as all other information that you share with us, will be true, accurate and honest;

2.7.2 you have not and will not deceive or mislead us in any way (including, without limitation, not withholding any information);

2.7.3 you are applying as yourself to participate in the Program; and

2.7.4 you will continue to be entirely truthful and accurate in answering any questions and/or supplying information to us whether verbally or in writing.

2.8 You agree to keep us informed of any change(s) to your circumstances and/or to the information set out in your Application Form and other documents completed by you and any other information that you share with us at any time in connection with the Program including without limitation any criminal charges, investigations, convictions and/or restraining orders which are brought against you or by you.

2.9 Please note, if you fail to provide certain information when requested, or the information you provide is incorrect, incomplete or out of date, we may not be able to perform our contractual obligations under the contributor agreement (such as allowing to participate in the Casting Process and/or the Program, if selected), and/or we may be prevented from complying with our legal obligations (such as you ensure safety).

2.10 We may, in our sole discretion, disqualify you and terminate the agreement between you and us at any time at any stage of the Casting Process, or of the Program itself (if selected), and/or withhold or reclaim any prize or other benefit awarded or due to be awarded to you as a result of your participation in the Program if:

- 2.10.1. you do not meet or comply with the Eligibility Requirements;
 - 2.10.2. you fail to abide by these Terms and/or, if applicable, the terms of any agreement between you and us and/or the applicable rules of the Program;
 - 2.10.3. you supply any untruthful, incomplete, inaccurate, or misleading details and/or information, you withhold any information, or you have deceived us or the Commissioner in any way including without limitation about your identity;
 - 2.10.4. you fail to follow any of our reasonable instructions or directions; and/or
 - 2.10.5. as a result of your conduct (including, without limitation, past conduct), you bring us, any co-producer, the Program and/or the Commissioner into disrepute, scandal, contempt or ridicule.
- 2.11. You agree to indemnify us and our assigns and licensees against any and all claims, losses and/or damages suffered directly or indirectly by us as a result of the breach, non-performance, or non-observance by you of any of your obligations and representations under these Terms and/or the Application Form including but not limited to any extra costs of casting/diligence and/or production of the Program.

3. GRANT OF RIGHTS

3.1. In the event that you are invited to participate in an audition, interview (whether face to face or online), recording and any other subsequent stages of the Casting Process, you agree to us photographing, filming and/or recording you and your voice, conversation and sounds (together the "**Contribution**") and using your Contribution for and in connection with Casting Process and/or production of the Program, in the Programme and/or associated publicity, in whole or in part, or not at all.

3.2. You irrevocably grant and assign to us by way of present assignment of present and future copyright, all rights of any nature in and to the rights, title, and interest in your Contribution so as to permit the fullest use throughout the world of the Contribution or any part(s) thereof by all means and in all media in connection with the Program or otherwise in perpetuity.

3.3. You also agree that any photographs, images, recordings (audio and/or visual) and/or any other materials you submit as part of the Casting Process and/or the production process for the Program and/or as part of your Contribution ("**Personal Media**") may be used in connection with the Casting Process and/or production of the Program (in whole or in part), featured in the Program and/or associated publicity, or not at all. We are under no obligation to return the Personal Media to you. Furthermore, you grant to us a royalty free worldwide perpetual licence for our use of the Personal Media and you confirm that you have all the necessary licences, rights and permissions (including, without limitation, from any individuals who may feature in the Personal Media) for our use of the Personal Media (in whole or in part) in the Program and shall provide us with details of these to us on request.

3.4. You grant us the right to use your name, voice, likeness, photographs and any biographical material, Personal Media and/or your Contribution for and in connection with the Program (including without limitation for publicity, promotion and sponsorship of the Program, any potential future series of the Program, and/or any ancillary or merchandising products, services or endorsements) by any medium or method whether now known or later developed throughout the world in all media in perpetuity.

3.5. You accept that we have the right to edit, copy, adapt and/or translate the Contribution and Personal Media as we see fit and you irrevocably waive the benefits of and agree not to assert any provision of law known as "moral rights" or any similar laws of any jurisdiction in respect of any Contribution and/or Personal Media.

3.6. You confirm that nothing in your Application Form and/or any other documents completed and/or submitted by you in connection with the Casting Process, the Program, your Contribution and/or the Personal Media will:

3.6.1. infringe the copyright or any other right of any third party;

3.6.2. breach any contract or duty of confidence;

3.6.3. constitute a contempt of court or expose us to any civil or criminal proceedings; and/or

3.6.4. otherwise be intended to bring us, any co-producer, the Commissioner and/or any other party into disrepute, scandal, contempt or ridicule.

4. CONFIDENTIALITY

4.1. You agree that you will not **at any time** disclose (directly or indirectly) or supply any information or materials (including but not limited to any photographs, audio recordings and/or visual recordings) to any person (including without limitation the press, friends or family and/or the public) by any means (including without limitation via social media) in relation to: (i) your application and/or the Casting Process; (ii) the Program (including but not limited to any filming and/or production location, other participants or applicants, the production crew, any challenges, tasks and/or activities, and/or the outcome of the Casting Process and/or any activity); (iii) the affairs of us, any co-producer and/or the Commissioner; and/or (iv) the contents of any and all agreements, correspondence and/or conversations between you and us; except where such information may already be legitimately in the public domain, is required by law to be disclosed, or where we have given you our prior written consent.

4.2. You further agree not to make any derogatory or critical comments or statements (whether orally or in writing) about the Program or any person involved with the Program, us, any co-producer and/or the Commissioner.

5. MISCELLANEOUS

5.1. We want everybody involved in the Casting Process and production of the Program in whatever capacity to be treated with dignity and respect and any form of unacceptable behaviour (such as but not limited to harassment or bullying) will not be tolerated.

5.2. By necessity we will process your personal data, including without limitation such special category data as you may share with us (e.g. relating to your health, race and/or criminal history) as part of the Casting Process and in connection with the Program. We will do so in accordance with all relevant data protection law and you can find out more information about how we process your personal data and who we may share such information with (such as co-producers and the Commissioner) on our website: <https://studiolambert.com/privacy/>

Where data is shared with the Commissioner, the Commissioner will act as an independent data controller for that data, and will treat it in accordance with the Commissioner's privacy notice: <https://press.amazonmgmstudios.com/us/en/privacy-notice>.

5.3. By providing information to us relating to another person, including but not limited to contact details, you confirm that you have fully explained to them the purpose of providing the information to us and have provided them with a copy of our privacy policy <https://studiolambert.com/privacy/>. References in this policy to EEA and EU privacy laws shall be deemed amended to refer to UK or EEA laws. Where data is transferred outside of the UK we rely on approved data transfer mechanisms, including legal exceptions, adequacy decisions, recognised frameworks (e.g. the EU-US Data Privacy Framework), and standard contractual clauses. If you are located in the UK or the EEA, you may contact us for a copy of the safeguards.

5.4. Any costs or expenses incurred by you in respect of applying for the Program or in respect of the Casting Process (such as phone calls, postage, broadband/Wi-Fi/data charges etc) will be your responsibility, unless we specify otherwise in advance.

5.5 We shall be entitled to assign, license or sublicense the benefit of any rights or permissions granted by you under these Terms to any third party.

5.6 It is understood and agreed that a breach by you of any of your agreements and obligations in these Terms may cause us irreparable injury and damage and you agree that we shall be entitled to seek injunctive or other equitable relief to prevent such a breach.

5.7 You agree that, if we are in breach of any our obligations hereunder or of law, your remedies shall be limited to the right (if any) to claim for damages actually suffered by you and under no circumstances shall you be entitled to seek to injunct, restrain, inhibit, enjoin or otherwise prevent the development, financing, production, distribution, exhibition and/or other exploitation of the Program and/or any allied and ancillary rights thereto.

5.8. We shall not be liable to you for any loss of earnings, loss of anticipated profits or savings, loss of publicity, loss of any contract, loss of business or goodwill, or any other incidental, consequential or indirect loss and/or damages and you expressly waive any rights thereto.

5.9 The provisions of clauses **Error! Reference source not found., Error! Reference source not found.**, 5.7 and 5.8 shall survive termination or expiry of your participation in the Casting Process and any agreements between us and you.

5.10 The arrangements set out in these Terms to do not create or give rise to any form of employment or work relationship and they do not constitute the provision by you of any form of goods or services.

5.11 These Terms were last updated on 10 December 2025. Please note that we may update and amend these Terms from time to time and it is your responsibility to ensure you review the Terms regularly to familiarise yourself with any changes

5.12. The Application Form, these Terms and any non-contractual obligations arising out of or in connection with it or its subject matter shall be construed in accordance with the laws of England and Wales and the parties submit to the exclusive jurisdiction of the courts of England.
