

BEAT LUKE LITTLER APPLICATION TERMS & CONDITIONS

For the purposes of these terms and conditions:

“Broadcaster” shall mean Netflix and any other television broadcaster, streaming platform and/or video-on-demand service which exhibits the Programme.

“Producer” shall mean Banijay UK Productions Limited t/a Workerbee and its parent, group and subsidiary companies, licensees and assigns.

“Programme” shall mean the television programme currently entitled "Beat Luke Littler" (working title).

“Contributor Privacy Policy” shall mean Producer’s Contributor and Talent Privacy Notice available at - <https://banijayuk.com/documents-contributor-privacy-notice/>

1. By submitting this application form you hereby acknowledge, warrant, confirm and agree that:

- a) you are aged eighteen (18) years or over or if applying on behalf of a minor, you confirm that the minor is twelve (12) years or older, that you are the parent or legal guardian with authority to undertake this application on the minor’s behalf, that you will execute any further documentation required by the Producer in connection with the minor's participation in the Programme and “you” from here on in shall refer to the minor;
- b) you have the right to legally reside in and/or travel to the UK for the production of the Programme;
- c) you are not employed and have not been previously employed or engaged by the Producer or the Broadcaster and you are not a live-in partner or immediate relative (i.e. mother, son, daughter, brother or sister) of an employee of the Producer or Broadcaster, any companies associated with the Producer, the Banijay group of companies (“Banijay Group”) or the Broadcaster;
- d) you are not currently, and have never previously been a Professional Darts Corporation (“PDC”) Tour Card holder;
- e) you are not subject to sanctions or restrictions preventing participation or receipt of any prize.

2. If you are selected as a contributor, the Producer has no obligation to produce the Programme or include you in the Programme even if you have been filmed. If the Programme is made there will be no obligation on the Producer or the Broadcaster to broadcast the Programme.

3. You understand that meeting the eligibility requirements or achieving a particular average, ranking or tournament result does not guarantee selection. The Producer reserves the absolute right to determine the number, identity and suitability of contributors participating in the Programme. Selection for the Programme is not a merit-based assessment of darts ability alone and the Producer may take into account any creative, editorial, production, welfare, legal, compliance, scheduling or other factors it considers relevant. The Producer's decisions regarding selection and participation are final and binding, no correspondence will be entered into in relation to such decisions and you agree not to challenge or appeal against those decisions.

4. Full details of any prize, winner selection criteria and payment arrangements will be set out in the contributor agreement and/or competition rules.

5. Any interviews, auditions, self-tapes, photographs, recordings and other contributions made during the selection process may be recorded and used by the Producer for casting, development and production purposes.

6. Unless expressly agreed otherwise in writing, applicants shall bear their own costs and expenses incurred in applying for or participating in the selection process and the Producer shall not be liable for cancellation, postponement, alteration or suspension of the application process and/or the Programme.

7. You shall not do anything which may bring the Producer or the Broadcaster into disrepute or prejudice the successful exploitation of the Programme and any such disrepute or prejudice may result in your disqualification from the Programme.

8. You confirm that, to the best of your and your parent and/or guardian's knowledge as appropriate, you do not have any physical, medical or mental health condition which would prevent safe participation in the auditions and/or the Programme and you agree to notify the Producer promptly of any relevant change.

9. You have answered all of the questions on the application form and will answer any other questions in any other part of the selection process fully, honestly truthfully and accurately and confirm that you have not misled or attempted to mislead the Producer in any way as to your identity, experiences, Criminal History (as defined below) or in any other way. You agree to keep the Producer informed of any change to these circumstances or the information and/or data set out in this application form or provided in any other part of the selection or production process (if you are selected to participate).

10. The Producer reserves the right at its sole discretion to suspend or terminate a participant's involvement in the Programme and/or withhold, withdraw or recover any prize where a participant has breached these Terms and Conditions, provided false information engaged in inappropriate, unsafe or unsporting conduct, fails to comply with the Producer's reasonable instructions, or where the Producer reasonably considers such action necessary to protect the welfare of contributors or the integrity of the Programme.

11. If you are selected to participate in the filming of the Programme you will be required to sign a separate contributor agreement, statement of health and any other further documents as may be requested by the Producer. You acknowledge that the Producer may conduct background checks in order to verify any of the information you have supplied and you agree to provide the Producer with any assistance or further information necessary to do this. This could include checks of information that is publicly available online, including information you have made public via social media. 12. All selected applicants will be asked to disclose details of any prior unspent criminal convictions, pending prosecutions, sanctions in relation to children and any civil proceedings they are involved in before taking part in the Programme ("Criminal History"). Further details as to the basis upon which we request and process your information can be found in the [Contributor Privacy Policy](#).

13. You own all rights in the photograph(s), videos and/or other material that you have submitted with this application form and/or may submit during the selection process and the Producer and the Broadcaster (and their licensees and assigns) shall be entitled to copy, edit and/or otherwise use the same at their sole discretion for the purposes of making, selling, promoting and exploiting the Programme or promotional material connected with it in all media, and you hereby grant the Producer

and the Broadcaster (and their licensees and assigns) all necessary rights and consents for the full period of copyright to enable them to do such acts.

14. If you submit a video as part of your application, you warrant that you own all rights in the video, that you are the only person featured in the video and that you have authority to upload the video. Your video must not contain any material which is in any way defamatory, obscene, unlawful, harmful, offensive or inappropriate or which infringes the rights of any third party or which is calculated to bring the Producer and/or the Broadcaster into disrepute.

15. You will not discuss any information concerning the Producer, the Broadcaster, the Programme (including any photographs) or your possible participation in it, with any other person or company, whether by means of discussion, letter, press and television interviews, social media postings or otherwise, at any time without the prior written consent of the Producer.

16. The Producer complies with the provisions of the Data Protection Act 2018 and the General Data Protection Regulation. The Producer will only process your personal data to the extent necessary to consider whether the Producer wishes you to be a potential candidate for the Programme and to contact you in relation to the Programme. The Producer will implement and maintain measures, in accordance with its security policies updated from time to time, to protect your personal data against accidental loss, unauthorised disclosure or access. Your personal data shall be held and deleted from the Producer's systems in accordance with the [Contributor Privacy Policy](#). You acknowledge that you have read, understood and agree to the Privacy Policy about the collection and use of your personal information by the Producer.

17. You understand that once this application form has been submitted no subsequent changes will be accepted by the Producer (save as may be required to update your personal details) and that in submitting this application form you are confirming that you have read and understood the information contained within the application form.

18. You will make yourself available at such times and locations as the Producer shall reasonably require in connection with the selection and production process.

19. Please note that the Producer may update and amend these Terms and Conditions from time to time and any changes will be posted on the Programme website but it is your responsibility to ensure you review these Terms and Conditions regularly to familiarise yourself with any changes.

20. These Terms and Conditions and any dispute or claim arising out of or in connection with them shall be governed by and construed in accordance with the laws of England and Wales.
