

## CASTING APPLICATION ELIGIBILITY REQUIREMENTS AND TERMS & CONDITIONS

To begin your application, please read and confirm the following Eligibility Requirements to proceed with the casting and application process, and potentially be selected to participate in the docuseries currently entitled “Angels Among Us” (the “Series”).

### PART I: ELIGIBILITY REQUIREMENTS

- 1) You must be at least 18 years of age as of April 6th, 2026. If selected, you will be required to bring a passport or driver’s license to castings as proof of age.
- 2) You must be a legal US resident and eligible to work in the US.
- 3) You are not currently, nor do you currently intend to be, a candidate for public office, and if there is any change in this representation prior to the initial exhibition of the Series in which you appear, you must immediately notify Producer (as defined below) at [vs-casting@boardwalkprods.com](mailto:vs-casting@boardwalkprods.com). Becoming a candidate before or around the time of the initial exhibition of the Series may under certain circumstances have legal implications on the exhibitor’s ability to exhibit the Series.
- 4) You are not currently, nor do you currently intend to be, a member of SAG-AFTRA, and you expressly acknowledge and agree that the production is non-SAG and non-union (unless Producer [as defined below] and VS [as defined below] decide otherwise in their sole discretion).
- 5) You are not currently represented by, signed to, or otherwise under contract with any agent, manager, modeling or talent agency, and no third party has any rights that would conflict with or limit your ability to participate in the Series or sign an exclusive representation agreement.
- 6) Greenway Pictures, Inc. (“**Producer**”), Victoria’s Secret & Co. and Victoria’s Secret Stores Brand Management, LLC (collectively, with Victoria’s Secret & Co., “**VS**”), and IMG Models, LLC (“**IMG**,” collectively, with VS the “**Production Partners**”) reserves the right to render ineligible any person who Producer or Production Partners determines, in its sole discretion, is sufficiently connected with the production, administration, judging, or distribution of the Series, such that his/her participation in the Series could create the appearance of impropriety. In making this decision, Producer and the Production Partners may consider whether you are, or know or have known anyone who is, or has been within the last two (2) years, an employee, officer, director or agent of any of the following:
  - (a) Producer, the Production Partners or any other person or entity involved in the development, production, distribution or other exploitation of the Series or any variation thereof;
  - (c) Any sponsor of the Series or its advertising agency; or
  - (d) Any person or entity supplying goods, services or prizes (as applicable) to the Series.

Please declare any such relationships to the Producer by emailing [vs-casting@boardwalkprods.com](mailto:vs-casting@boardwalkprods.com). If you become aware of any such relationships after completing this application, please immediately notify the Producer in writing.

- 7) If you are selected as a potential participant, you will be expected to attend (at your sole cost and expense) an in-person casting call during May / June 2026 in one of the following cities at the specific locations, on the dates, and at the times specified by Producer (in its sole discretion and subject to change): Los Angeles, Miami, Houston and Chicago. Please note that the cities for the casting calls are subject to change and additional cities may be added at the Production Partners’ sole discretion without notice. The Production Partners will narrow the applicant pool to potential participants at any time they deem appropriate. The criteria for such narrowing the applicant pool to potential participants will be at the sole discretion of the Production Partners.

- 8) If you are selected as a potential participant, you will be expected, as a condition of your ongoing participation, to execute additional agreements, including without limitation waivers and release agreements required by Producer and its Production Partners or any of their licensees, successors or assigns.
- 9) If you are selected as a participant, you will need to be available to the production on dates determined by Producer in its sole discretion and be willing to travel to various locations as part of production. Production is currently anticipated to occur in July 2026 and September 2026 (dates and duration to be determined by Producer in its sole discretion and subject to change). If you are selected as a participant and Producer requires you to travel as part of production, any such required travel will be paid for by Producer, pursuant and subject to the specific travel policies and requirements of Producer and its Production Partners.
- 10) The foregoing eligibility requirements may be amended, revised or changed at any time and in any fashion in Producer's sole discretion.

## **PART II: APPLICATION TERMS & CONDITIONS**

1. You give the following representations, warranties, acknowledgements, consents and releases:

(a) By signing below, I represent, warrant, acknowledge, and agree that: (i) I have read and I meet and agree to be bound by the eligibility requirements; (ii) I have completed this application honestly and accurately; (iii) materials submitted as part of my application do not contain any work of any third-parties, or where they do, I have obtained all necessary consents, permissions and releases to use such work and such materials do not: (a) violate any right of privacy or publicity of any person, whether contractual, statutory, common law or otherwise and/or (b) infringe any intellectual property rights of any third party; (iv) if any of the information in this application is found to be false or incomplete, this will be grounds for dismissal from the Series participant selection process, and/or from the Series contest (if any), if selected; (v) even if I meet the eligibility requirements, Producer has no obligation to further contact me, interview me, and/or select me as a participant; (vi) even if I am selected as a participant, Producer has no obligation to conduct the Series contest (if any) or produce the Series and Producer (or its licensees and assigns) has no obligation to exhibit it, even if produced; (vii) I will keep strictly confidential all information about the Series including without limitation any details any castings, Producer and the Production Partners that I may acquire during the participant selection process and/or during my participation in the Series (if applicable), except as otherwise expressly provided in this application; (viii) all decisions by Producer concerning selection of the participants are final and not subject to challenge or appeal; and (ix) except to the extent required by law, Producer has no obligation to return any materials submitted by me as part of the application whether or not I am selected as a participant.

(b) By submitting this application, I consent to the recording, use and reuse by Producer, the Production Partners, and any of the Released Parties (as defined in Paragraph 3 below) of my voice, actions, likeness, name, appearance, biographical material, and any information contained in, derived from or obtained in connection with my application to be a participant in the Series or in any materials submitted by me in connection with my application (collectively "**Likeness**"), as edited, altered, or modified by Producer, the Production Partners or by any of the other Released Parties, in any and all media now known or hereafter devised, worldwide in perpetuity, in or in connection with the Series or any other work. I agree that Producer or the Production Partners or any of them may use all or any part of my Likeness, and may alter or modify it regardless of whether or not I am recognizable. I further agree that the Producer and the Production Partners exclusively own all right, title, and interest (including, without limitation, all copyrights) in and to any and all recordings made by them (the "**Recordings**"). Without limiting the foregoing, I further grant to Producer, the Production Partners and their respective subsidiaries and affiliates, for good and valuable consideration, receipt of which is hereby acknowledged, the right, but not the obligation, to incorporate, edit, alter, modify, use and/or exploit any and all materials, including video footage shot and/or controlled by me, stills, my archival materials and other materials and related and ancillary materials, as well as any and all other elements related thereto owned or controlled by me (including without limitation names, music, logos, verbiage, trademark, tradenames, any other intellectual property [e.g., drawings, designs, etc.]) provided in connection with my application and any other materials that I have provided or may provide in the future in connection with my application or the Series (collectively, the "**Materials**"), and all or part of the Materials and my Likeness, in any and all media now known or hereafter devised, worldwide, in perpetuity, in or in connection with the Series or any other work. Without in any way limiting the foregoing, if I perform or include any music (other than music supplied to me by Producer) in

connection with my application for the Series, I represent and warrant that I own all rights to such music, and I grant Producer the right to record, reproduce and publicly perform any such music in and in connection with the Series or any other work. Without in any way limiting the waivers and releases set forth herein, I waive any claims to royalties of any kind, whether accruing now or in the future, from Producer and the Production Partners for the use of any such music, including, without limitation, any applicable copyright, public performance, mechanical and synchronization royalties. I further agree that Producer, the Production Partners and their respective subsidiaries, affiliates, licensees, and assigns may use my Likeness and the Materials in connection with any promotion, publicity, marketing or advertisement. I grant the rights hereunder whether or not I am selected to participate in the Series in any manner whatsoever. I understand that I will not be paid any money for giving Producer, the Production Partners and their respective subsidiaries, affiliates, licensees, and assigns these rights or for signing this application.

(c) I authorize Producer and any person or entity designated by Producer to investigate, access and collect information about me, about any of the statements made by me in my application, any supporting documents and any other documents that I have signed or provided or do sign or provide in connection with my application to be selected as a participant in the Series, or any other written or oral statements I make in connection therewith, to the maximum extent permitted by law. Without limiting the foregoing, I irrevocably authorize Producer and any person or entity designated by Producer to secure information about me and my experiences from my current and former employers, associates, friends, family members, educational institutions, government agencies, credit reporting agencies, any branch of the military, and any references I have provided, and I irrevocably authorize such parties to provide information concerning me. I hereby unconditionally and irrevocably release and forever discharge Producer, the persons or entities designated by Producer, and all such parties and persons from any and all liabilities arising out of or in connection with any such investigation. To the maximum extent permitted by law, I specifically authorize investigation of my employment records, and government records, including but not limited to my motor vehicle records, criminal records, civil records, military records, and consumer report(s). I acknowledge and agree that any such information obtained by Producer or by any person or entity designated by Producer pursuant to this paragraph or otherwise may be used for purposes of selecting participants in the Series or in the course of producing the Series, and may be described or otherwise related in and in connection with the Series, in and in connection with another program, and in and in connection with any advertising, promotion or publicity for the Series or other program, to the maximum extent permitted by law.

(d) I understand that the participant selection process will involve subjective decisions made by certain individuals selected by Producer and the Production Partners in their sole discretion. I understand that the participant selection process may also involve subjective decisions made by the public. I further understand that those certain individuals, the Production Partners, Producer and other persons or entities may be acquainted with or have some familiarity with some or all of the applicants to varying degrees. I understand and agree that all participant selection and elimination decisions shall be final and binding on me in all respects and shall not be subject to challenge or appeal.

(e) By submitting this application, I hereby acknowledge that, if selected to potentially participate in the Series, my name, image, and likeness may be used in or to publicize the Series. By submitting this application, I hereby waive any rights of privacy or publicity, any and all claims of defamation and "false light," and/or any other rights of a similar or dissimilar nature in connection with the Series and I hereby agree not to assert any claim of any nature whatsoever against any party related to the subject matter hereof.

(f) Any offer from Producer and the Production Partners to move forward in the casting process, including becoming a participant in the Series, may be subject to: (a) my execution of a participant agreement in the form presented by Producer; (b) my execution of an exclusive representation agreement with IMG (the "IMG Agreement") in the form presented by IMG; and (c) my provision of additional information and submission to a background check and such other examinations, assessments, interviews and screening procedures as Producer or the Production Partners may require. I acknowledge and agree that there will be additional terms and conditions set forth in the participant agreement and IMG Agreement that are not set forth herein, and I will have the opportunity to read and consider both the participant agreement and the IMG Agreement prior to execution if such agreements are presented to me.

2. **CONFIDENTIALITY**. I understand that Producer, the Production Partners and Network are involved in a competitive industry in which confidentiality is a valuable asset. I acknowledge that, in my capacity with Producer,

the Production Partners and Network, I may be provided with Confidential Information and maintaining this Confidential Information is vital to the success of the Series and Producer's, the Production Partners' and Network's businesses. Whether or not I am selected to be a participant on the Series, I shall keep in strictest confidence and shall not, and shall not authorize or cause others to, directly or indirectly, use or disclose to any third party at any time (i.e., prior to, during, or after the taping or exhibition of any episode of the Series) any of the following, which is the exclusive property of Producer or the Production Partners: any information or materials that I may read, hear or otherwise acquire or learn in connection with or as a result of my participation in or in connection with the Series, including without limitation, any information or materials concerning or relating to Producer or to the Production Partners, the business of Producer or the Production Partners, any program produced by Producer, including, without limitation, any information concerning or relating to the Series, the participant selection process including without limitation details of castings, the Series applicants, the Series participants, the location(s) of the Series, the events contained in the Series, the outcome of any episode of the Series, and the contents of this application or any other agreement or document that I sign, have signed or receive from Producer or the Production Partners at any time (collectively, the "**Confidential Information**"). I acknowledge and agree that my obligations with respect to confidentiality set forth in this application shall continue in perpetuity or until terminated by Producer and/or the Production Partners by giving me written notice of termination. In no event will I have the right to terminate my confidentiality obligations under this application. I acknowledge that in the event I breach the confidentiality or any other provisions of this application, my breach may, in the sole discretion of Producer or the Production Partners, result in my being disqualified to participate as a participant in the Series. I further acknowledge that a breach by me of any of the confidentiality provisions of this application would cause Producer and the Production Partners irreparable injury and damage that cannot be reasonably or adequately compensated by damages in an action at law, and, therefore, I hereby expressly agree that Producer and the Production Partners shall be entitled to injunctive and other equitable relief to prevent and cure any breach or threatened breach of any of the confidentiality provisions of this application by me. I understand that nothing in this paragraph or this application generally prevents me from: (a) discussing or disclosing information about conduct that I have reason to believe is unlawful; or (b) discussing or disclosing any matter I am entitled to discuss or disclose under applicable law. I understand that nothing in this paragraph or this application restricts me from reporting or providing information related to potential legal violations to any governmental agency or entity (e.g., SEC, OSHA, DOJ) without notifying Producer or the Production Partners ("**Whistleblower Activity**"). Producer and the Production Partners will not retaliate against me for any Whistleblower Activity, and nothing in this application requires me to waive any monetary award that I may legally be entitled to as a result of Whistleblower Activity.

3. **RELEASE AND AGREEMENT NOT TO SUE.** To the maximum extent permitted by law, I irrevocably and unconditionally release each of the Released Parties from any and all liability arising out of my participation in or in connection with the Series, including, without limitation, the recording of my Likeness, the Recordings, and the Materials, my participation in the participant selection process, and any exploitation of the Series, my Likeness, the Recordings or the Materials, on any legal theory (including failure to adequately compensate me, infliction of emotional distress, illness, personal injury, rights of privacy and publicity, defamation, or false light), regardless of whether caused by the negligence or willful misconduct of the Released Parties (collectively, the "**Released Claims**"). The term "**Released Parties**" shall mean and refer to Producer, Network (as defined below), the Production Partners, Boardwalk Pictures, Inc., any other licensees or assignees of the Series, the Materials and/or any Recordings, the other participants in the Series, all other persons and entities connected with the Series, all parent, subsidiary, related and affiliated entities, licensees, successors, assigns, sponsors and advertisers of each of the foregoing, all of the respective directors, officers, principals, executives, on-air talent, employees, agents, contractors, partners, shareholders, representatives and members of each of the foregoing, and the respective heirs, next of kin, spouses, guardians, representatives, executors, administrators, successors, licensees and assigns of each of the foregoing.
4. As used herein, "**Producer**" shall include, its licensees, successors, and assigns, and each of their respective officers, directors, shareholders, employees, agents, and representatives. As used herein, "**Network**" shall mean the television network, program service, platform, or offering that telecasts, distributes, or otherwise exhibits the Series. I agree that Producer may license, assign, and otherwise transfer this application and all rights granted by me to any person or entity.
5. I acknowledge that there is a possibility that after the execution of this application, I may discover facts or incur or suffer claims which were unknown or unsuspected at the time of execution, and which if known by me at that time

may have materially affected my decision to execute this application. I agree that by reason of this application, and the releases contained in the prior paragraphs, I am assuming any risk of such unknown or unsuspected facts and claims.

6. **MEDIATION & ARBITRATION.** WHERE ANY CONTROVERSY, DISPUTE, OR CLAIM IN CONNECTION WITH THIS APPLICATION OR MY PARTICIPATION IN THE SERIES (INCLUDING THE ENFORCEMENT, SCOPE, OR APPLICABILITY OF THIS AGREEMENT TO ARBITRATE) (A “DISPUTE”) ARISES AND CANNOT BE RESOLVED BETWEEN THE PARTIES, THE PARTIES AGREE TO FIRST TRY TO RESOLVE SUCH DISPUTE THROUGH CONFIDENTIAL MEDIATION. IF MEDIATION IS UNSUCCESSFUL, THEN ALL DISPUTES, INCLUDING THE SCOPE OR APPLICABILITY OF THIS AGREEMENT TO ARBITRATE, SHALL BE RESOLVED BY FINAL AND BINDING ARBITRATION BEFORE A SINGLE NEUTRAL, ADMINISTERED BY JAMS OR ITS SUCCESSOR (“JAMS”) IN ACCORDANCE WITH ITS COMPREHENSIVE RULES AND PROCEDURES (COLLECTIVELY, “JAMS RULES,” AVAILABLE AT WWW.JAMSADR.COM AND PROVIDED IN HARD COPY UPON REQUEST). THE JAMS RULES FOR SELECTION OF MEDIATORS AND ARBITRATORS WILL BE FOLLOWED, EXCEPT THAT ANY MEDIATOR OR ARBITRATOR WILL BE: (A) LICENSED TO PRACTICE LAW IN NEW YORK, OR (B) A RETIRED JUDGE. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, I AGREE TO WAIVE MY RIGHT TO COMMENCE, TO BECOME A PARTY TO, OR TO BE OR REMAIN A PARTICIPANT IN, ANY GROUP REPRESENTATIVE, CLASS, COLLECTIVE, OR HYBRID CLASS/COLLECTIVE ACTION IN ANY COURT, IN ANY ARBITRATION, OR IN ANY OTHER FORUM ARISING FROM OR RELATING TO THIS APPLICATION OR MY PARTICIPATION ON THE SERIES IN ANY WAY, UNLESS OTHERWISE PROHIBITED BY APPLICABLE LAW. I AGREE THAT ANY CLAIM BY ME SHALL BE HEARD IN ARBITRATION WITHOUT CONSOLIDATION OF SUCH CLAIM WITH ANY OTHER PERSON OR ENTITY’S CLAIM, EXCEPT AS OTHERWISE AGREED TO BY PRODUCER AND ME. UPON THE CONCLUSION OF ANY ARBITRATION PROCEEDINGS, THE ARBITRATOR SHALL RENDER FINDINGS OF FACT AND CONCLUSIONS OF LAW AND A WRITTEN OPINION SETTING FORTH THE BASIS AND REASONS FOR ANY DECISION REACHED. ALL SUCH PROCEEDINGS WILL BE CONDUCTED IN NEW YORK COUNTY. MY AGREEMENT TO MEDIATE AND ARBITRATE ANY AND ALL DISPUTES SHALL EXTEND TO THE RELEASED PARTIES. THE PARTIES AGREE THAT WITH RESPECT TO THE MEDIATION OR ARBITRATION OF ANY FEDERAL OR STATE CLAIM I BRING THAT ARISES FROM UNWAIVABLE PUBLIC RIGHTS, WHETHER STATUTORY OR NONSTATUTORY, THE FOLLOWING SHALL APPLY: THE BURDEN OF PROOF SHALL BE THE SAME AS IT WOULD BE IN A JUDICIAL PROCEEDING AND THE DECISION SHALL BE BASED ON THE INTERNAL SUBSTANTIVE LAWS OF THE STATE OF NEW YORK, TO THE EXTENT THAT SUCH LAWS DO NOT CONFLICT WITH THE FEDERAL ARBITRATION ACT, WHICH GOVERNS THIS AGREEMENT TO ARBITRATE, THE ARBITRATOR MAY AWARD ANY REMEDY THAT WOULD HAVE BEEN AVAILABLE IN COURT; THE PARTIES SHALL BE PERMITTED DISCOVERY ADEQUATE TO SECURE THE NECESSARY INFORMATION TO PRESENT SUCH CLAIM OR DEFEND AGAINST SUCH CLAIM; AND PRODUCER SHALL PAY ALL TYPES OF COSTS THAT ARE UNIQUE TO MEDIATION OR ARBITRATION. THE PARTIES WILL OTHERWISE BEAR THEIR OWN FEES AND COSTS, INCLUDING ATTORNEYS’ FEES AND EXPERT FEES. ANY DISPUTES AS TO THE REASONABLENESS OF COSTS AND EXPENSES SHALL BE DETERMINED BY THE ARBITRATOR. IN THE EVENT OF ANY ACTUAL OR ANTICIPATED BREACH BY ME OF MY EXCLUSIVITY, PUBLICITY, OR CONFIDENTIALITY OBLIGATIONS UNDER THIS APPLICATION, PRODUCER MAY SEEK AND OBTAIN INJUNCTIVE AND OTHER EQUITABLE RELIEF FROM ANY COURT OF COMPETENT JURISDICTION. PRODUCER MAY ALSO PURSUE OTHER REMEDIES AGAINST ME FOR ANY BREACH OF THIS AGREEMENT. I AGREE THAT GIVEN THE UNIQUE NATURE OF THE ENTERTAINMENT INDUSTRY, AND THE IRREPARABLE DAMAGE TO PRODUCER, THE PRODUCTION PARTNERS, NETWORK AND THEIR LICENSEES THAT WOULD RESULT FROM DELAYING OR PREVENTING THE ADVERTISING, MARKETING, PROMOTION, DISTRIBUTION, EXHIBITION OR OTHER EXPLOITATION OF ANY PROGRAM PRODUCED HEREUNDER (INCLUDING THE SERIES), I MAY NOT SEEK OR OBTAIN INJUNCTIVE RELIEF IN CONNECTION WITH THIS APPLICATION. TO THE GREATEST EXTENT PERMITTED BY APPLICABLE LAW, MEDIATION AND ARBITRATION SHALL BE CONFIDENTIAL (EXCEPT AS BETWEEN THE PARTIES AND THIRD PARTIES INVOLVED IN DISCOVERY), INCLUDING PLEADINGS, EXHIBITS,

**AND/OR TESTIMONY. A SUCCESSFUL PARTY MAY MAKE APPLICATION TO THE ARBITRATOR FOR AN AWARD OF ATTORNEYS' FEES AND/OR COSTS, AND THE ARBITRATOR MAY AWARD SUCH FEES AND COSTS TO THE EXTENT CONSISTENT WITH APPLICABLE LAW. IF ANY PORTIONS OF THE DISPUTE RESOLUTION PROVISIONS IN THIS APPLICATION ARE FOUND TO BE INVALID, ILLEGAL, OR UNENFORCEABLE, THAT PORTION SHALL BE SEVERED FROM THE REST AND SHALL NOT AFFECT THIS AGREEMENT TO RESOLVE ALL DISPUTES THROUGH MEDIATION AND ARBITRATION.**

7. **APPLICATION OF FAA AND GOVERNING LAW.** I agree that the Federal Arbitration Act, 9 U.S.C. § 1, et seq. ("FAA") governs any and all of the arbitration provisions contained herein and any arbitration proceeding related to or arising from this application. Notwithstanding the foregoing, this application shall be construed and enforced in accordance with the substantive laws of the State of New York, to the extent they do not conflict with the FAA, without regard to the state's conflict of law provisions. The exclusive venue for any dispute held to be non-arbitrable, shall be the Supreme Court of the State of New York located in New York County and the United States District Court for the Southern District of New York, and the parties submit to the in personam jurisdiction of those courts and waive any objections thereto.
8. **ELECTRONIC SIGNATURES.** This application may be executed by original, facsimile or electronic signature in a form acceptable to Producer. Any signed copy of this application delivered by facsimile or electronic transmission shall for all purposes be treated as if it had been delivered containing my original signature, and shall be binding upon me in the same manner as though an original signed copy had been delivered.
9. **SEVERABILITY.** The illegality, invalidity or unenforceability of any provision of this application shall in no way affect the validity or enforceability of any of the remainder of this application, which shall be enforced to the maximum extent permitted by law.
